#### **New Business:**

- Anthony reported that a Grant has been approved by CoE City Council to fund a fitness court to be developed at the proposed Elk Meadows Park location. No date has been set for when development will begin.

- 4. Cars are parking at the corner of Bruhn & Bondgard, often up to the stop sign. This is a known parking violation that obscures turns onto Bondgard. City code enforcement will be asked to review and add signage to enforce parking regulations.
- 5. Underground water springs on either side of Sigrist Dr. E. are becoming more active again. CofE Public Works have determined there's little that can be done to fix the issue. CofE street sweepers can be dispatched more frequently to keep the area clear of algae and trash.
- 6. Recommendation was made by a Community member to install speed bumps on Bondgard to enforce the speed limit down Bondgard Ave E. This request has been made to CoE Public Works before with no resolution. EPD have set up speed limit signage previously with mixed results. Anthony will revisit this topic with Public Works.
- 7. Watson fence repair: vendor will meet Anthony late Feb 2020 to inspect the site and submit a quote.
